Conditions of Employment: Must consent to a background check in order to qualify as a gaming employee.
Must obtain and maintain a gaming employee Certificate of Registration from the Saskatchewan Liquor and Gaming Authority (SLGA).

Other Information: Willing to work shift work including evening, weekends and graveyards.
Ability to work in an environment that is exposed to tobacco smoke and high noise levels.
Ability to lift up to 10 kg.
Able to stand and walk for long periods of time.
Possession of a valid drivers license would be an asset.

Main Duties: Reporting to the Facilities Manager and under the supervision of the Facilities Supervisor, the Custodian is responsible for picking up trash in and around the gaming floor; Emptying all trashcans in casino and removing trash from building; Emptying ashtrays and wiping down machines that are not in use; Providing basic customer assistance to patrons with questions regarding directions and games; Cleaning tables after hours and emptying trash in the Live Games area; Shampooing carpets during scheduled times; Vacuuming all carpeted areas in the casino; Cleaning offices and break rooms in the administrative areas; All other duties as assigned by the Facilities Manager and/or Facilities Supervisor.
